

Macquarie Grammar School

Year 7 to 11 Scholarship

1. Definition

A Scholarship is offered to a scholar (student) who is of a high academic standard and is exceptionally gifted. It is offered to assist a scholar to reach her or his academic potential by granting them part or full payment of tuition fees and other expenses through sponsorship. This is made to support a student's education and is awarded on the basis of academic or other achievement.

Scholarship tests are designed to identify and distinguish between students of high academic ability. They are more difficult than the regular achievement tests the students had sit for in schools. They are tests that **assess** how a student demonstrates higher-order critical thinking skills.

2. Considerations

Before applying for a Macquarie Grammar School (MGS) Scholarship, the student's parents should consider their family's financial situation and ensure that undertaking an MGS Scholarship is within their financial capacity, especially as international students are required to cover the expense of Guardianship and Homestay arrangements. Exchange rates also fluctuate and can affect affordability. The MGS Scholarship should be used as intended.

3. Scholarships

Scholarship A

The MGS 100% Tuition Fees Scholarship with Sponsored Cash payment by Flylink Aviation College Australia for two (2) students (Top Scholars) only includes:

- Tuition fees to cover the cost of study for up to one academic year where school age students are studying as fee-paying international students, up to a maximum of \$32,000 AUD per annum, which equates to 100% scholarship on tuition fees only.
- This Scholarship will offer the top two (2) scholars an extended scholarship that includes Cash Payment in Australian Dollar sponsored up to AU\$3000.
- High School Preparation (HSP) tuition fees, where incurred, up to \$4800 AUD /term. These fees are only for English Language Study.
- A dedicated Student Services Officer for the duration of the Scholarship who provides services including pre-departure briefings, advice on health and travel insurance, advice and assistance relating to accommodation and payment of allowances.

Scholarship B

The MGS 20 - 60% Tuition Fees Scholarship for up to 10 students only includes:

- Tuition fees to cover the cost of study for up to one academic year where school age students are studying as fee-paying international students, up to a maximum of \$32,000 AUD per annum, which will vary upon the scholarship offered. The balance of fees are payable directly to Macquarie Grammar School (MGS). This Scholarship will only provide discounts for international tuition fees for up to 10 scholars.
- High School Preparation (HSP) tuition fees, where incurred, up to \$4800 AUD / term will vary, subject to the scholarship attained. These fees are only for English Language Study and are payable directly to MGS.
- A dedicated Student Services Officer for the duration of the Scholarship who provides services including pre-departure briefings, advice on health and travel insurance, advice and assistance relating to accommodation and payment of allowances.

The MGS Scholarship does not include:

- A travel allowance, passport or visa expenses to travel to or from Vietnam to Sydney, Australia.
- A settling in fee.
- A monthly stipend from parents to contribute to the student's living costs while in Sydney.
- Health and travel insurance for the duration of their overseas study.

An MGS Scholarship may be sponsored by Private Sector Organisations for the duration of the student's Scholarship Program. This may include benefits provided for the students but paid directly to MGS, such as Tuition, Guardianship and Homestay.

4. Eligibility

4.1 Applicants

Applicants for an MGS Scholarship must:

- Be nominated by their Agent after being screened on his/her academic record and for financial viability to cover the stipend required for living expenses while studying at MGS.
- Be a Vietnamese citizen seeking to study at MGS. Applicants cannot undertake an MGS Scholarship if they hold dual citizenship or permanent residency in Australia; or in which they have previously been a citizen or permanent resident of Australia.
- Be enrolled in Years 7 to 11 at MGS and complete the HSC in Year 12.
- Be between 12 and 18 years of age (inclusive) on 1 January 2022.

- Undertake the Higher School Certificate in Year 12, as a continuum of their studies.

4.2 Host Location

The MGS Scholarship will be conducted in Hanoi and Ho Chi Min, Vietnam.

Scholars must not travel to a Host Location or region within a Host Location for which the Australian Government's Smartraveller travel advice recommends 'Do not travel' (see www.smartraveller.gov.au). Host Locations for which the Smartraveller travel advice recommends 'Reconsider your need to travel' are eligible, but applicants should inform themselves carefully of the risks and think seriously about the need to travel to that country or region before applying. Applicants must acknowledge in their Scholarship agreement that they have considered the risks carefully and investigated safety precautions before deciding to travel.

Scholars who are awarded a scholarship must study at Macquarie Grammar School at 225 Clarence Street Sydney, only.

5. Selection Criteria

5.1 Considered Criteria

Applicants will be assessed on the following criteria in their written applications and their performance at interview:

a. Academic excellence at the tertiary level (60 per cent weighting)

Assessment of this criterion will relate to

- i. The applicant's academic grades at school over the last three (3) years, and
- ii. Ungraded academic achievements, such as academic awards and commendations or other examples of academic excellence at school level. The applicant's communication skills, higher-order cognitive and critical thinking skills and engagement in learning will also be assessed.

b. Leadership in the community (10 percent weighting)

Assessment of this criterion will relate to the applicant's demonstrated leadership in the community, including volunteer and not-for-profit roles and/or activities they have undertaken in their local community or at school.

c. Adaptability and Resilience (20 per cent weighting)

Assessment of this criterion will relate to the applicant's ability to adapt to a different environment, cope with being away from family and friends and demonstrate resilience in the face of challenges that s/he may face.

d. Sport, Co-Curricular and Extra-Curricular Activities (10 per cent weighting)

Assessment of this criterion will relate to the applicant's involvement in a broad range of activities outside of the classroom, such as: sport, debating, chess, music, public speaking, camping or orienteering, etc.

5.2 Selection Process

The table below summarises key dates and steps in the selection process:

20 th February to 31 st March 2020	Scholarship Programme guidelines published and advertised. Applications Opens \$50 AUD registration fee per application for Pre-Assessment
30 th March 2019	Submissions of Applications close at 11.59pm Australian Eastern Standard Time (AEST) on the 30 th March 2019. Nominations must be made through an agent.
20 th February 2020 to 31 st March 2020	Pre-Assessment of Student Registrations online, \$50 AUD per application
11 th April 2020	Scholarship test conducted in Hanoi.
12 th April 2020	Scholarship test conducted in Ho Chi Minh City.
20 th May 2020	Selections are finalised. All successful and unsuccessful applicants are notified of the outcome of their application.
5 th June 2020	Scholars are announced and their details are published on the MGS website.
3 rd August 2020	Scholars commence their Scholarship Program on 3 rd August 2020 for Junior Years (7 – 9)
28 th January 2021	Scholars commence their Scholarship Program on 28 th January 2021 for the Senior Years (10 & 11)

5.3 Nominations

Students must be nominated by their Agent in order to apply.

Each Agent is asked to conduct an internal process to nominate up to 20 unranked students.

Agents will consider the eligibility and selection criteria when conducting the nomination process.

Nominations must be submitted through MGS website or directly with MGS. The MGS Administration Manager for Scholarships will provide advice on how to submit nominations.

The following details about applicants will be requested in the nomination form:

- name
- gender
- date of birth
- email address
- mobile phone
- School year in which the nominee is enrolled
- Academic Transcripts (official)
- Other information indicating involvement in co-curricular or extra-curricular activities

5.4 Written Applications

MGS will contact nominees through their Agent and provide instructions on how to submit the application. Applications must be submitted through the MGS website or directly with the school.

The main component of the written application involves answering questions related to the four selection criteria (*refer to Section 5.1*).

Applications may be disregarded, offers revoked or the Scholarship Programme terminated if it is the belief of MGS, in consultation with the Department of Foreign Affairs and Trade, that false or misleading information has formed a component of an application.

Referee Reports

Applicants must supply two referee reports when submitting their application. A referee must be able to comment substantively on the applicant's abilities and experience with respect to the selection criteria, and must hold a position that gives their comments credibility (e.g. a position in the applicant's school or community). At least one report must be prepared by an academic referee.

Applicants should consider carefully their referees, as their reports may add considerable value to an application through the assessment process.

Supporting Documents

Applicants must submit the following documentation in addition to a completed application form:

- Evidence of Vietnamese citizenship (copy of birth certificate, current passport or citizenship certificate)
- A letter of current enrolment from their school.
- A current, complete-to-date official Academic Transcript from their school.

5.5 Selection Process

Scholars are selected through a competitive, merit based selection process against selection criteria and other considerations set out in Sections 5.1. Scholarships are awarded to eligible applicants to support their student while at MGS.

All applications submitted by the closing date will be subject to eligibility checks.

Eligible applications will then be shortlisted by MGS against the selection criteria. All staffs involved in selection process have commensurate skills and experience to assess applications and are required to complete a Conflict of Interest Declaration.

Shortlisted applicants will be advised in April between the 1st and 3rd and an interview over SKYPE will be scheduled during mid April. The interview panels may comprise Senior MGS Staff, members of the business community, academics, or other appropriate individuals.

The PEO/Headmaster will approve final Scholarship outcomes based on the advice of the interview panel.

5.6 Acceptance Process

All successful and unsuccessful applicants will be advised of the outcome of their applications by the 20th May 2020.

5.7 Offer of Scholarships

Applicants who are offered a Scholarship must accept and sign a Scholarship Agreement, and be able to satisfy the visa requirements of Australia.

5.8 Police Checks

All successful applicants will be required to undergo a police check. It is an important consideration of MGS that a Scholar will enhance the reputation of the school. A criminal record will not automatically disqualify an applicant from receiving a Scholarship. However, if a successful applicant is found to have a criminal record or conviction then MGS may revoke or refuse to grant a Scholarship.

5.9 Support Services Organisation

Successful applicants will be allocated a Student Services Officer to assist with Scholarship logistics such as health and travel insurance, accommodation and payment of allowances.

6. *Scholarship Agreement*

Macquarie Grammar School (MGS) will enter into a Scholarship Agreement with the Scholar (student). If the Scholar commences the Scholarship Program before the Scholarship Agreement is signed and executed, MGS will not be liable for any expenditure incurred before the date of execution.

The Scholarship Agreement will detail the successful applicant's responsibilities in relation to the Scholarship Program and outcomes that must be achieved. It will also set out the conditions and offer of the Scholarship Program as well as arrangements relating to (but not limited to):

- payment of entitlements
- leave of absence entitlements
- pre-departure advice and assistance
- assistance regarding return arrangements to Australia
- travel and health insurance
- minimum attendance requirements for attending school
