\*Invoices must be paid by the due date indicated on the invoice or a late fee of \$300 per month will be applied. Non-payment of fees or late fees will result in the cancellation of enrolment.

\*If you do not receive an invoice on the invoice date, please contact us immediately so we can issue you with another copy and in order for you to avoid a possible late payment fee.

\*\$1300 of administration and cancellation fees are applied when a student withdraws his/her enrolment prior and/or after the commencement date. This condition does not apply to unsuccessful VISA applicants.

### 1. Payment Information

- 1.1 All fees and charges are subject to change year to year. Please contact us to confirm the latest fee structure.
- 1.2 All invoices are issued in Australian dollars.
- 1.3 Any overdue invoices are applied to a late fee of \$300 per month.

- 1.4 An outstanding balance of fees and charges may result in the student being denied commencing a new term and prejudice the student's Visa status.
- 1.5 Our preferred payment method is Electronic Fund Transfer. Refer to **2. Method of Payment.**

- 2.3 1.5% Surcharge fee is applied for the payment is made from your credit card.

## 3. Withdrawal and Cancellation

- 3.1 Prior to Commencement

New students who are non-starters but have made a partial payment of School Fees with a Visa granted are restricted to transfer to another Education Provider. The School has no obligation to refund any fees and other charges which are related to the applied course and any preparation.

- 3.2 After Visa Granted

In circumstances in which the Student does not commence their course(s) for any other reason Macquarie Grammar School will refund 60% of tuition fees paid in advance minus the Application Fee of \$550.00 and the Enrolment Fee of \$3,000.00.

- 3.3 Unsuccessful Visa Applicant

New students who are non-starters but have made a partial of School Fees with a Visa rejected are entitled to receive a refund. A Refund Request Form needs to be accurately filled and submitted to the MGS Finance Department.

The refund process will take 14 to 28 working days from the day the School receives the correctly completed refund form. The refundable amount will be all monies paid, except the application fee and the Administration Fee.

- 3.4 Withdrawal of Students After Commencement

For current students who wish to withdraw from the School, the parents must provide a minimum of **Two Terms** written notification to the Headmaster. Failure to give such notice will result in a 'Penalty Fee' which is equivalent payment of two terms of tuition fees. Please refer to the Deferring, Suspending and Withdrawal Policy.

In case of exclusion expulsion caused by misbehaviour or breaking of school rules by the student, no refund is applicable.
