### Payment Information

An Early Payment Discount (1.5% of Tuition Fee only) is applicable when fees are paid within 15 days after the invoice has been issued.

School Fee Invoices are issued and sent out 90 days prior to the start of the term. Your cooperation in organising to settle down the payment in-time is much appreciated.

All fees are subject to change.

Any overdue account will be subject to an administrative charge of \$300 per month.

An outstanding balance of any fees and charges will result in the student being denied to commence a new term.

Enrolment of the second family will attract the Sibling Discounts of 5% of Tuition Fee and 10% for the third and subsequent children.

## Withdrawal and Cancellation

**Prior to Commencement:** New students who are non-starters but already have made a part payment of the School Fee (1<sup>st</sup> Initial Payment and/or 2<sup>nd</sup> Instalment) are strictly restricted to transfer to another Education Provider. The School has no obligation to refund any paid fees and other fees which are related to course applied for preparation for the student.

**Withdrawal of Students enrolment after commencement:** For current students who wish to withdraw from the school, the parents must provide a minimum of **six month** written notification to the Headmaster. Failure to give such notice will result in a 'Penalty Fee' which is equivalent to two terms tuition fees. Please refer to the Deferring, Suspending and Withdrawal Policy.

\*\$1,300 of administration and cancellation fees are applied when a parent withdraws their child's enrolment prior and/or after the commencement date.

In case of exclusion or expulsion caused by misbehaviour or breaking of school rules by the student, no refund is applicable.
